This has reference to your RTI application No. Nil dated 22-06-2016 seeking information under RTI Act 2005. Please note our point-wise reply to the queries raised by you are as below :

- 1) Ministry of Environment and Forests, Govt of India, had issued Environmental Clearance to establish the Numaligarh Refinery at Pankagrang, Golaghat prior to construction of the Refinery. Numaligarh Refinery never released any polluted water or any kind of poisonous material into Chengamara-Jan. Only a storm water drain is going out from Numaligarh Refinery which ultimately joins with the Chengamara-Jan on the northern side of the Refinery.
- 2) Numaligarh Refinery had never disposed off any polluted water through pipeline into River Dhansiri. Only treated effluent water from Effluent Treatment Plant of the Refinery after proper testing was disposed earlier through pipeline. However, disposal of treated effluent water was stopped from the Refinery since October, 2006. Now there is no any discharge from the Refinery and entire quantity of effluent water is reused/recycled within the Refinery.
- 3) No polluted water is released by NRL to the agricultural land of Panka-Gaon and NRL doesn't have any record of alleged damage to agricultural land.
- 4) Numaligarh Refinery do not release any oil contaminated polluted water outside its premises.
- 5) Carrying out survey of Chengamara-Jan is not under our purview and no such record is available.
