- 1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

PRE QUALIFICATION CRITERIA (PQC)

Participating bidders for the tender shall meet all the qualification criteria given as below:

I. The bidder must have valid enlistment with Engineers India Limited (EIL)/IOCL/BPCL/HPCL for the indented items (CS with SS cladded vessels). Valid Enlistment certificate shall be submitted alon g with the bid.

(Bidder's Enlistment shall be valid ending last day of the month previous to one in which the origin al tender bid due date falls. If the validity is due to expire within 2 months from the original tender bid due date, the vendor shall submit proof of re-application for enlistment and submit a declarati on that NRL reserves the right to cancel the Purchase Order or reject the supplied items if the required enlistment is not valid at the time of supply).

II. Bidder shall have experience of successfully supplying at least one (01) Stainless Steel (SS) c ladded pressure vessel of **minimum 2 m³ capacity** for hydrocarbon service to **any Indian Crud e Oil Refinery** during the last 10 years, ending the last date of the previous month from the date of original tender.

Note:

- i) Copies of Purchase Order(s) along with PO supporting documents shall be submitted as proof.
- ii) Date of the submitted Purchase Order (PO) shall be considered as the date of execution.

PQC Supporting Documents:

- 1. The bidder shall submit copies of Purchase Orders (POs) along with corroborative document s such as:

REQUIREMENT OF AUTHENTICATION AND SUBMISSION OF DOCUMENTS:

- a. Submission of authentic documents is the prime responsibility of the bidder. Wherever NRL h as concern or apprehensions regarding the authenticity/correctness of any document, NRL reserve s the right to get the documents cross-verified from the document issuing authority.
- b. Bidder should ensure submission of complete information/documentation in the first instance itself, in support of their fulfilling the qualification/eligibility criteria. NRL reserves the right to complete the evaluation based on the details furnished without seeking any additional information. Subsequent to the submission of the bid, bidders are not allowed to change the price or substance of the bid.
- c. BIDDERS ARE TO NOTE THAT no further communication may be done to ascertain their prequalification at the time of evaluation of bids. The offers with incomplete / irrelevant documents / an omalies may be straightway rejected without any communication. Hence, bidders are informed to take utmost care while submitting their prequalification documents, annexures etc. and also, must clarify their doubts/deviations from NRL at least 10 days prior to Bid submission date. After closing of bids, deviation shall not be considered that may have other implication.
