**1. EVALUATION & ORDER AWARD:**

- ❖ Evaluation will be done on “ITEM WISE LOWEST OFFER BASIS” and the items are SPLITABLE.

## **2. PRE-QUALIFICATION CRITERIA:**

- ❖ BID-Qualification Criteria:
- ❖ The bidder must be a manufacturer or an authorized dealer of roller chains. In case of authorized dealer, a valid dealership certificate is to be submitted along with their offer.
- ❖ The bidder must have prior experience in the supply of chains to any PSU/Govt. Organisation/Crude Oil Refinery in the last 5 years counting from tender due date. Relevant PO/WO copies along with Tax invoice/Delivery challan/ Third party inspection release note are to be submitted as proof of past experience.
- ❖ However the criteria for prior experience will be relaxed if the bidder is MSME or Startup and meets the quality and technical specification described in the tender, subject to submission of valid supporting documents by the bidder.

### **SPECIAL NOTE TO THE BIDDERS:**

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.

**b) The relaxation pertaining to Prior turnover, prior experience and price benefit shall be applicable for MSE and Start up bidders for this tender, subject to submission of valid supporting documents by the bidder**

- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder:** The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.

- iii) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
