NOTICE INVITING TENDER

Two parts bid **ONLINE (E-tender)** item rate offers requested from competent contractors for following work:

Name of Work:	Preparation of Feasibility Report, Basic Drawing and Project Estimation of On Grid Rooftop Solar system for Residential Township of Numaligarh Refinery Ltd (NRL).

BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

- The intending bidders for above tender should meet the qualifications as given below:
Past Experience of having successfully completed similar works during last 10 years ending last month should be either of the following:
 - Three similar completed works costing not less than Rs. 1.16 Lakhs each, or
 - Two similar completed works costing not less than Rs. 1.54 Lakhs each, or
 - One similar completed work costing Rs. 1.93 Lakhs.

***Similar Works:**

- The vendor should have minimum 03(three) years of previous experience of carrying out “Preparation of Feasibility Report, Basic Engineering Drawing and Project Estimation of Rooftop Solar system” for a minimum 500 KW capacity within any Industry in India. Alternatively, the party having experience of detail engineering and execution the Solar Project of minimum 500 KW in minimum 01 installation in India which has been commissioned and successfully running. **Documentary evidence in the form of Work Order and Job completion certificate is to be submitted along with the bid.**
- Vendor should have the experience of carrying out each job listed in the “Scope of Work”. However, it is not necessary that all jobs defined in the “Scope of Work” are to be covered in each contract. Party may furnish documents of as multiple contracts as required as a proof of carrying out all the jobs listed in the Scope of Work.
- For completion of the assignments at site, party shall depute its expert in solar system and experienced Civil Engineer having minimum 03 (three) years’ experience.

Note: (i) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof

(ii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall form the basis for considering experience and value of work executed under the private organization.

- Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs. 1.16 Lakhs**. The bidder must submit copy (ies) financial documents – Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

SPECIAL NOTE TO THE BIDDERS:

- **Prior turnover and prior experience will be relaxed if the bidder is Micro and Small Enterprise or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.**

Documents to be submitted in support of 'Micro & Small' and 'Start Ups':

Apart from the documents listed above, bidders who are willing to avail the benefit of 'Micro & Small Enterprises' and 'Start Ups' are required to submit the following documents.

For availing the benefits of 'Micro & Small Enterprise'

(i) MSE bidders must submit Udyog Adhaar Memorandum (UAM) number.

In case bidder submits the UAM No. in the bid but same is not declared on the CPPP, such bidder will not be eligible to claim benefits.

(ii) The MSE registration shall be valid as on date of placement of order:

The registration must be for the items/category of items/services relevant to the tendered items/category of items /services. (For details please refer **Annexure – X** of the tender document)

For availing the benefits of 'Start Ups'

Bidder who intends to participate as 'Start-up' company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India.

OTHER REQUIREMENT:

It is to be noted that experience as main contractor will only be taken cognizance of for the purpose of assessing qualifying criteria. However, authorized sub-contractors under principal contractors can also be considered provided their works completion certificate is issued by the client organization in case of job executed elsewhere under PSUs, limited companies, Government Departments, Quasi government and autonomous bodies. However, in case of sub-contractors under contractors engaged by NRL, the works completion certificate issued by the main contractor will also be acceptable provided the same is endorsed in original by Engineer-in-charge of NRL in terms of job description and value.

For accepting experience as sub-contractor(s) or contractors under Private Organizations, in addition to the requisite certificates (letter of award and job completion certificate etc.) TDS certificate issued by principal contractor / private organization shall form the basis for considering experience and value of work executed.

3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
 - i. Provident Fund Registration Number.
 - ii. ESI registration number.
 - iii. Income Tax PAN Number.
 - iv. GST Registration Number.
4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. **Accordingly, the bidder shall submit a self declaration as per format enclosed with Tender Document.** It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
