Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

1. **OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
2. **Buyer Added text based ATC clauses**
 - 1. Bidder must go through the attached ATC document & Technical specifications document (Including commercial / technical annexures therewith).**
 - 2. Bidder shall provide duly filled, signed and sealed ATC document & Technical Specifications document (Including Annexures therein) with Unpriced / techno-commercial offer.**
 - 3. Technical specifications attached shall be final. Any amendment / changes / modification shall be intimated through corrigendum / addendum in this GeM Tender.**
 - 4. Pre Bid Meet will be conducted online / VC/ MS Team as per schedule, any changes may be intimated on GeM Portal. For MS Teams / Online Meeting Link, please mail at praveen.lal@nrl.co.in.**

PRE BID MEET : MINUTES OF MEETING

Date: 15.10.2025

Pre Bid meeting was conducted via MS teams on above date at 5:00 PM in the presence of NRL Commercial and Technical Member relating to tender. Meeting was attended by below prospective bidders-

1. AV Valves, Agra
2. GM Valves, Rajkot
3. Valves Industries
4. Zed Valves, Ahmedabad

A. Introduction

The meeting commenced with brief introductions of the participants from both NRL and the prospective bidders.

B. Commercial Discussion

The NRL representative outlined the key commercial aspects of the tender i.e.,

- Non-applicability of MII policy
- Item Wise evaluation (29 Schedules)
- Submission of CPS (Contract performance security) after contract within 10 days of the contract date, subject to contract value.
- Submission of annexures which are given as applicable in the checklist of ATC.

Most of the bidders asked for tender due date extension to post Diwali holidays, as their offices will mostly be closed. NRL Reply - It was noted, as the due date falls in Diwali Holidays. Thus, NRL requested bidders to mail the same / raise via GeM for future record purposes.

C. Technical Discussion

The NRL representative displayed the PQC & same was explained thoroughly during the meeting, to avoid PQC related rejections during technical evaluation / unpriced offer evaluation. The bidders were requested to submit the documents related to PQC in full compliance.

D. Tender Conditions

No changes to the tender terms and conditions were envisaged during meeting.

E. Conclusion

The meeting concluded with a request to all prospective bidders to participate in the tender process and submit their bids in full compliance.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
