Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as

indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

- 2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

6. Buyer Added Bid Specific ATC

A. PRE-QUALIFICATION CRITERIA (PQC):

The bidder must have successfully executed at least one project involving supply, fabrication, dismantling, and erection/commissioning of a complete stack or part thereof in any Indian crude oil refinery or PSU with in India during the last 10 (ten) years, reckoned from the last day of the month immediately preceding the month in which the original bid due date falls.

PQC Supporting Documents:

- 1. The bidder shall submit copies of **Purchase Orders (POs)** along with **corroborative documents** such as:
- o General Arrangement Drawing (GAD) and,
- o Inspection Release Note (IRN) / Tax Invoice / Dispatch Challan, to substantiate compliance with the above experience requirement.

Note: For the purpose of PQC evaluation, the **date of the Purchase Order (PO)** shall be considered as the **date of execution**.

- 2. All documents submitted in support of PQC compliance **must be** duly sealed and signed by bidder.
- 3. PO's issued by **EPC/PMC organizations** shall be acceptable **only if the end customer is an Indian crude oil refinery or PSU within India**.
- o In such cases, the **end customer's name must be explicitly mentioned in the PO** or must be confirme d through an **authentic documentary communication** (e.g., letter/email) from the end customer.
- o Any such confirmation submitted must clearly state the **contact details (email ID, phone number, etc.)** of the end customer, enabling **verification by NRL as and when required**.

B. <u>REQUIREMENT OF AUTHENTICATION AND SUBMISSION OF DOCUMENTS</u> (For information only):

- 1. **AUTHENTICATION:** Submission of authentic documents is the prime responsibility of the bidder. Where ver NRL has concern or apprehensions regarding the authenticity/correctness of any document, NRL reserves the right to get the documents cross-verified from the document issuing authority.
- 2. Bidder should ensure submission of complete information/ documentation in the first instance itself, in sup port of their fulfilling the qualification/ eligibility criteria. NRL reserves the right to complete the evaluation based on the details furnished without seeking any additional information. Subsequent to the submission of the bid, bidders are not allowed to change the price or substance of the bid.
- 3. All documents submitted for PQC compliance shall be duly sealed and signed by bidder.
- 4. In case of any conflict amongst various documents enclosed with the tender/ RFQ/ SOR item description, the most stringent requirement shall govern and NRL EIC decision in this regard shall be final.

BIDDERS ARE TO NOTE THAT no further communication may be done to ascertain their prequalification at the time of evaluation of bids. The offers with incomplete / irrelevant documents / anomalies may be straightway rejected without any communication. Hence, bidders are informed to take utmost care while submitting their prequalification documents, annexures etc and also, must clarify their doubt s/deviations from NRL atleast 10 days prior to Bid submission date. After closing of bids, deviation shall not be considered that may have other implication.
