#### PRE-QUALIFICATION CRITERIA (PQC):-

## **PQC 1: Past Experience:**

**A)** Bidder should have minimum 3 (Three) Years of Experience in executing Similar\* nature of service. *Note: The 3 years'* experience can be sum of duration of more than one contract.

- **B)** Past Experience of having successfully completed similar works\* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
  - ➤ One similar work costing not less than Rs.6.49 Lakhs
  - > Two similar works costing not less than Rs.5.19 Lakhs each and
  - ➤ Three similar works costing not less than Rs.3.89 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual start date and completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited. Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

\*Similar Works: Providing documentation and facility management services/data entry services/office assistances to Public Sector/Govt. Companies/reputed Corporate to their satisfaction.

PQC 2: The bidder should have an operating office at Siliguri.- Necessary certificate in this respect to be submitted along with their offer.

### PQC 3: AVERAGE ANNUAL TURNOVER, of the last 3 financial years, shall be at least Rs. 3.89 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three 3 financial years mentioned above refers to immediate 3 preceding financial years wherever the last bid submission date is after 30th Sept. In case of tenders having last bid submission date up to 30th September, and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the 3 years prior to preceding financial year will be considered.
