If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

#### **Supply of Spare Flame Scanner Heat Insulating Nipple**

#### A. Bid Qualification Criteria:

The bidder shall be OEM of Industrial flame scanner or OEM's authorized repres entative of Industrial flame scanner for Indian Territory. If the bidder is not OEM, valid authorization certificate from the OEM shall be submitted by the bidder along with the offer.

**BIDDERS ARE TO NOTE THAT** no further communication may be done to ascertain their pre-qualificatio n at the time of evaluation of bids. The offers with incomplete / irrelevant documents / anomalies may be s traightway rejected without any communication. Hence, bidders are informed to take utmost care while su bmitting their pre-qualification documents, annexures, supporting documents etc and also, must clarify th eir doubts/deviations from NRL at least 01 week prior to Bid submission date.

PO copies submitted with BID, as per requirement of technical and financial criterion, shall only be considered for evaluation purpose. Post closing of BID, no new PO copies shall be considered as per Govt procure ment guideline.

#### **B.** Technical Specification:

Heat Insulating Non Metallic Nipple for SIL certified IR/UV flame scanner of P&U area; Size: 1"NPT(M) X 80 mm, Both side NPT Male Threaded, Aaxial Orientation, Operating temperature upto 200 DEGC or better.

#### C. Others

- 1. **Final inspection** shall be done by NRL end user after the items are received at NRL warehou se and if any deviations are observed, NRL reserves the right to reject the items with due intim ation to the vendor. The rejected items have to be replaced by the vendor free of cost.
- 2. **Packing & Forwarding:** The supplied items shall be properly packed and tagged with their r espective NRL Item codes and details for safekeeping and identification of items. Each items s hall be packed as per standard packing to protect filter from dust, moisture, foreign particles e tc.
- 3. **Delivery period** shall be max 8 weeks from the date of placement of PO.
- 4. Documents to be provided with material supply:
- a) Guarantee/Warrantee certificate as per tender provision. In case, Bidder being a dealer, guar antee/warrantee certificate shall be validated from their principal.
  - 5. All other terms and conditions shall be guided by NRL GPC.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export

experience.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
