- A bidder can opt for any of the groups or all. However, he has to quote for all the items of a group as per BOQ format which is mandatory requirement for evaluation of their bids. Otherwise their offer shall be rejected from the said group.
- Evaluation will be done on GROUP-WISE LOWEST OFFER BASIS, which is NOT SPLITABLE.

#### PRE-OUALIFYING CRETERIA

- a. The bidder has to be the original equipment manufacturer or authorized dealer of a reputed manufacturer operating in Eastern India.
- b. Certification / License USFDA or European CE approved or equivalent Govt approved certifying statutory body in India.

#### Note:

- (i) As per CVC Circular no. 03/01/12 dated 13/01/2012 Para 3. a), both Manufacturer and their Authorized dealer cannot bid simultaneously in the same tender. If both of them participated in the same tender, then both the offers shall be rejected without any further communication.
- II. Mandatory documents to be submitted in support of the PQC:
  - i. Documents in support of 'a' of the PQC.
  - ii. Copy of certificate / license issued by designated statutory body in support of 'b' which should be valid at the time of bidding.
  - iii. Copy of Work Order of having supplied similar equipment / system to a hospital / medical college / OHC/ Health Unit in the Govt sector in the last 10 years to be reckoned from the bid due date.

### **SPECIAL NOTE TO THE BIDDERS:**

a) The relaxation of Prior Turnover and Prior Experience (Indicated in the tender document) will not be applicable for Micro and Small Enterprise (MSE) or Startup bidder for the subject tender as it is related to Public safety. b) Have to indicate the all taxes, duties i.e. GST & freight as per BOQ.
