1. EVALUATION & ORDER AWARD:

Evaluation will be done on "OVERALL LOWEST OFFER BASIS" and items are NOT SPLITABLE.

2. PRE-QUALIFICATION CRITERIA:

Participating Bidders shall meet all the following prequalification criteria (technical):

- 1. The Technical solution must be vetted by OEM and the bidders will have to submit authorization from OEM mentioning the Tender / RFQ number for participating in this tender.
- 2. Installation and configuration of the SD-WAN solution and integration with existing NRL Setup will be under the scope of the OEM and will be done through OEM Certified Engineer.
- 3. Post installation warranty maintenance services will be directly provided by the OEM.
- 4. The items should be supplied to Refinery Site, NRL.
- 5. Bidder must clearly mention about the technical deviation of the offered model (if any).
- 6. Detailed technical literature of the product offered is to be enclosed along with the bid.
- 7. The bidder will have to submit the technical bid (point wise in a tabular format) mentioning the compliance / non-compliance of the technical specifications mentioned in the tender.
- 8. The bidder should have experience in supply and installation of SD-WAN in PSU Government / Private Organizations in India. Proof of the same (Purchase Order Copy) has to be submitted along with the bid.
- 9. OEM has to be mentioned in Gartner Magic Quadrant for WAN edge infrastructure.
- 10. OEM has to have dedicated technical support team in India to provide 24x7 technical support.
- 11. Bidder must include all applicable Hardware / cloud Subscription / software license cost while quoting so that all features mentioned in the tender are available from Day-1.
- 12. Bidder shall note that all SDWAN components are of critical nature to the organization and any component of Chinese origin or designed & manufactured in China shall not be acceptable and shall not be offered by bidders.

SPECIAL NOTE TO THE BIDDERS:

Item performance is directly related to uninterrupted operation and is necessary for safety of man and machine. Thus to ensure that the items procured have reliable and proven performance PQC cannot be relaxed for MSE/start-up vendor for the subject tender. As such Pre-Qualifying Criteria mentioned in the tender should be complied by all participating bidders.
