#### 1. **EVALUATION & ORDER AWARD**:

Evaluation will be done on "ITEM WISE LOWEST OFFER BASIS" and items are SPLITABLE.

#### 2. PRE-QUALIFICATION CRITERIA:

- 1) Bidder shall be OEM of offered thermocouple and Thermowell.
- 2) Proven Track record (PTR): The Bidder shall be reputed original manufacturer of thermocouple and thermowell with established presence and proven track record in Petroleum Refineries in India. Bidder shall submit performance certificate from end user of any Indian refineries as documentary evidence to prove that their thermocouple and thermowell supplied in the past 5 years reckoned from date of NIT has performed satisfactorily in Steam/ Hydrocarbon services for at least 6 months.

#### **SPECIAL NOTE TO THE BIDDERS:**

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) Item performance is directly related to uninterrupted operation of plant and is necessary for safety of man and machine. Thus to ensure that the items procured have reliable and proven performance PQC cannot be relaxed for MSE/start-up vendor for the subject tender. As such Pre-Qualifying Criteria mentioned in the tender should be complied by all participating bidders
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader/dealer.
