Contract Period:	Contract duration is only for 70 days for RTA 2023 from the date of site handover. (30 days for shutdown period and 40 days for Pre-shutdown & Post shutdown job requirement.) However, contract will be valid for 15 (Fifteen) months from the date of work order. Tentative date of RTA 2023 is Mar -Apr 2023 which might get rescheduled also due to unforeseen circumstances. Bidders should take note of this fact

PRE-QUALIFICATION CRITERIA:-

The subject job being 'Work Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

- A) **Past Experience** of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

***Similar Works:**

- a) Bidder must have experience of executing heat exchanger overhauling job (Overhauling includes tube bundle pull out and insertion) in any Crude Oil Refinery/ Petrochemicals during last ten years ending last month from date of tender. Proof of experience - work orders against completed jobs and corresponding completion certificates are to be furnished.
Or,
b) Bidder must have experience of executing heat exchanger overhauling job (Overhauling includes tube bundle pull out and insertion) in any Crude oil Refinery/ Petrochemicals in shutdown/ Refinery Turn around during last ten years ending last month from date of tender in case of a composite/ LSTK contract, heat exchanger overhauling job (minimum 50 nos) to be clearly mentioned in the scope/ SOR of work order submitted by the bidder as a proof of experience. However, during bid evaluation total work order value (completed job) containing the above-mentioned job shall be considered.

Note:

- i) The offer, not in line with PQC, as above may be straightway rejected without any communication. Hence, bidders are informed to take utmost care while submitting their prequalification documents, annexures etc. and bidders must clarify their doubts/ deviations from NRL within allowable period prior to Bid submission date.

B) AVERAGE ANNUAL TURNOVER : As mentioned above

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
