- 2. Each page of the entire tender document should filled up along with Annexures , duly sealed & signed by bidder and uploaded the same in the online portal.**
- 3. Bidder must indicate the no of chemicals & respective quantities in KG per annum for 1st year, 2nd year & 3rd year from date of contract considering all the aspects as per technical details & upload in technical bid as ANNEXURE-A and indicating all other relevant details / information. Offer without ANNEXURE-A (Duly filled up , sealed & Signed) shall not be considered for evaluation.**
- 4. Bidder has to quote unit price only in KG as per ANNEXURE-B _PRICE schedule against 1st year, 2nd year & 3rd year from the date of contract indicating the required chemicals.**
- 5. The evaluation shall be carried out on overall basis considering total no of chemicals & respective quantities for 03 years and unit rates for 03 years with loading of taxes, duties and other charges as applicable & single L1 shall be decided.**
- 6. Release order shall be placed against the Rate Contract based on NRL requirement from time to time basis.**
- 7. Performance Bank Guarantee: Bidder should confirm to furnish PBG of 10% of total order value valid for a period of 03(three) years from the date of contract with a claim period of 03(three) months thereafter.**

8. Pre-qualifying criteria:

- The technical knowhow of the specialist supplier and guidance to be rendered for monitoring and troubleshooting through out the consumption of the chemicals shall be considered as important factor which has to be mentioned by the bidder at the time of tender.
- Vendor should give list of present users with details of ongoing treatment of similar boiler with job completion certificate with boiler details & it should be from Indian PSU only. Vendor has to give manufacturing certificate or dealership certificate from reputed manufacturer in case of dealer. Without these certificates no offer will be evaluated.
- Each batch of material must contain test certificate, MSDS, Material data sheet, shelf life. The vendor is to mention the parameter and test method of offered chemical for verification at NRL QC Lab at the time of offer along with active content.
