- a) Party must have supplied "Neoprene Rubber Gasket" to any Petroleum Refinery or MS/HSD Marketing Terminal in last 5 years ending date of enquiry. Party must submit following documents along with the offer as proof of compliance:
 - 1) Purchase order for "Neoprene Rubber Gasket"
 - 2) Proof of acceptance of material of the same purchase order in either of the following ways
 - i. Third Party Inspection clearance certificate/ release note or
 - ii. Goods receipt copy or
 - iii. Payment receipt copy.

Non fulfillment of all the above Pre-Qualifying Criteria (PQC) will lead to disqualification of bidder.

SPECIAL NOTE TO THE BIDDERS:

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.
