PRE-QUALIFICATION CRITERIA:

- A. **Past Experience** of having **successfully completed** similar works* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
 - ➤ One similar work costing not less than = Rs. 19.71 Lakhs
 - > Two similar works costing not less than = Rs. 15.77 Lakhs each and
 - ➤ Three similar works costing not less than=Rs. 11.82 Lakhs each.

<u>Similar Works</u>: Operating Guesthouse/Transit Accommodation including catering services in any Govt. organization/ PSU or reputed corporate firms for a minimum period of 3 years.

The bidder has to submit details SOR and completion certificate of executed job in support of the same.

Note - 1: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and thereafter at @0.58% for every completed month ending last day of the month proceeding the month in which last date of original bid submission falls.

Note-2:

- 1. The bidder must have experience of successfully operating Guesthouse/Transit Accommodation including catering services in any Govt. organization/ PSU or reputed corporate firms for a minimum period of 3 years. Job Completion certificate from the PSU/Firm shall be required in support of past experience.
- 2. The Office of the Agency shall be located in Mumbai or Delhi/NCR. A documentary proof of offices in Mumbai shall be enclosed. The company should be reputed, experience & financially sound. Proof to this effect may be enclosed.
- 3. In case of partnership firms, a copy of the partnership agreement, or General Power of Attorney duly attested by a Notary Public, should be furnished on stamped paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney. The attested copy of the certificate of registration of firm should also be enclosed along with the tender.

4. Bidders or their authorized representative (s) (limited to 2 persons only) are advised to attend the **Pre- Bid discussion at NRL 3rd Floor, Bay-View Apartment, Hill Road, Bandra (W), Mumbai (India)**. The bid of any Vendor/ Contractor not participating in the pre bid meeting shall be rejected.

B. Average Annual Turnover: During the last 3 financial years, shall be at least Rs. 11.82 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C. Possession of Valid GST registration certificate:

Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.
