2.1 The E-Bid should be prepared in Two Parts as per the following details.

- ii) PART - II : Price Bid

2.2 Only online offer shall be considered against the subject enquiry. For details please visit our e-tendering portal <http://eprocure.gov.in/eprocure/app>

2.3 This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

2.4 **Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.**

2.5 Subsequent Corrigendum/ Addendum (if any) shall be published in our e-tendering portal <http://eprocure.gov.in/eprocure/app>

2.6 Any modification of the Bidding Document, which may become necessary as a result of the bidder's query/ pre-bid discussion, shall be published in e-tendering portal (<http://eprocure.gov.in/eprocure/app>) through the issue of an Addendum/ Amendment/ Corrigendum/Clarifications.

2.7 **EARNEST MONEY DEPOSIT** : Not Applicable.

2.8 **HOLIDAY LISTING:** Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have

the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

2.9 PRE-QUALIFICATION CRITERIA (PQC):

The bidders who intend to participate in the tendering process shall meet all the following minimum requirements and only such bidders shall be pre-qualified technically for further evaluation:

The bidder shall have experience of supplying stud along with nuts of ASTM A 193 GR B16 & A194 GR.4/7 to any PSU/Govt. establishment in last ten years ending 01.11.2022.

The bidder must furnish a copy of purchase order/Work order along with Inspection release note (IRN)/Invoice as a proof to the same.

Bidders submitting WO/PO of Supplying ASTM A 193 GR B16 & A194 GR.4/7 shall be considered as complying PQC for all items.

(RELEVANT COPIES OF PO AND INSPECTION RELEASE NOTE/DISPATCH CHALLAN/ INVOICE ARE TO BE SUBMITTED AS PROOF OF THE SAME.)

Note:

- i. *NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credential against PQC. Authentication may be verified with the issuing authorities, by way of direct communication to NRL over official e-mail IDs / Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid. Proper address for communication, including e-mail ID of the issuing authority should be provided along the tender document.*
- ii. *Offer will be considered only when NRL is satisfied with experience and capability of the tenderer to take up this work.*

Note: Above supporting documents are required to be uploaded by bidder along with un-priced techno-commercial bid only. It is the responsibility of the bidder to upload the above supporting documents along with their un-priced techno-commercial bid for availing relaxation on Prior Turnover and Prior Experience (if applicable in this tender). In case of non-receipt of above documents along with bidder's un-priced bid, no further communication in this regard will be carried out to ascertain bidder's qualification as 'MSE bidder/

Startup' and relaxation on Prior Turnover and Prior Experience (if applicable in this tender) will not be passed on to bidder.
