- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.

**EVALUATION OF TENDER:** Evaluation will be done on "OVERALL LOWEST OFFER BASIS" and items are NOT SPLITABLE.

### A. PRE-QUALIFICATION CRITERIA:

- 1. Bidder's offered items shall be manufactured as per compliance of IEC/EN 62561 (refer item specification). Manufacturing test reports from accredited laboratory to be submitted.
- 2. Bidder shall have the experience of successfully completed execution of both external and internal lightning protection system as per IS/IEC 62305. Bidder shall submit Purchase order and completion certificate from at least one Government agency.
- 3. Bidder must attend Pre-bid meeting at NRL site and understand the complete scope of work before submitting bids for the tender.

The intending bidders shall have to furnish proof of their pre-qualification along with the Techno-commercial bid. Copies submitted in support of credentials shall be self-attested. Pre-qualification criteria will be checked at the time of techno-commercial evaluation of the offer. Bidders are to know that no further communication may be done to ascertain their pre-qualification. The offers with incomplete /irrelevant documents / anomalies may be straightway rejected without any communication. Hence, bidders are advised to take utmost care while submitting their prequalification documents at the time of offer.

# **B. TECHNICAL CRITERIA:**

- Experiences of executing contract value of similar work (\*) completed during last 10 years ending last day of previous month should be either of the following:
  - $\triangleright$  One similar work costing not less than = **Rs. 44.72 Lacs**
  - ➤ Two similar works costing not less than= Rs. 35.78 Lacs each and
  - ➤ Three similar works costing not less than=**Rs. 26.83 Lacs** each.

The value of past experience shall be adjusted at a simple rate of 7% for every completed year (ending last day of the month, preceding the month in which bids are invited) or part thereof.

# (\*) "Similar works" means:

- Bidder shall have the experience of successfully completed execution of both external and internal lightning protection system as per IS/IEC 62305. Bidder shall submit Purchase order and completion certificate from at least one Government agency.
- Bidders to submit *notarized* documentary evidence in support of desired past experience.

# **C. FINANCIAL CRITERIA:**

**AVERAGE ANNUAL TURNOVER** during the last 03 years, ending 31st March of the previous financial year shall be at least **Rs. 26.83 Lakh**.

In support of average annual turn over bidder should submit copies of audited P/L account(s) statements. In case audited financial statement is not available for the immediate preceding year, bidders may submit turnover certificate from a registered Chartered Accountant Form.

# **SPECIAL NOTE TO THE BIDDERS:**

- a) The entire work covered under this contract shall be treated as "Works Contract".
- b) The relaxation of Prior Turnover and Prior Experience (Indicated in the tender document) will not be applicable for Micro and Small Enterprise (MSE) or Startup bidder for the subject tender as it is related to Public safety & Critical Operation. As such Pre-Qualifying Criteria mentioned in the tender should be complied by all the participating bidders.
- c) Have to indicate all the taxes, duties i.e. GST & freight as per BOQ.

# **Price preference for MSE Bidder:**

The Tender being a Works Contract of Composite Nature Price Preference as per Public Procurement Policy for Micro and Small Enterprise (MSEs) ,Order 2012 issued vide Gazette Notification dated 23.03.12. will not be applicable for this tender.
