Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Extension of Canteen Building and Construction of Entrance Gates at Siliguri Marketing Terminal of NRL.

Earnest Money Deposit:	Rs.2,69,000.00. (Rupees Two Lakh Sixty-Nine Thousand Only)
Contract Period:	9 months from the date of site handover.

PRE-QUALIFICATION CRITERIA: -

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:

- **One** similar work costing not less than **Rs.67.14 Lakhs**, or
- **Two** similar works costing not less than **Rs.53.71 Lakhs each**, or
- **Three** similar works costing not less than **Rs.40.29 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls. **The values specified above are executed values, exclusive of GST / Service tax.**

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** Civil Construction works of buildings under Petroleum Companies / Fertilizer / power Sector / Railways / Govt. Departments along with civil and electrical works in a single tender.

Bidders shall submit necessary documents including completion certificate, work order copy etc. along with the offer to establish their work experience in line with the PQC. No provisional completion certificate will be considered

C) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least **Rs.40.29 Lakhs**.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

D) Possession of Valid GST registration certificate: Please refer tender document and annexures for more details.

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
