MSE bidders are required to upload Udyam Registration Certificate (as explained in Annexure-X) instead of the EMD deposit receipt.

#### PRE-QUALIFICATION CRITERIA:

- **A)** Past Experience of having successfully completed similar works\* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:
- ➤ One similar work costing not less than Rs.45.43 Lakhs, or
- **Two** similar works costing not less than **Rs.36.34 Lakhs each**, or
- Three similar works costing not less than Rs.27.26 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

CONTRACTUAL PERIOD in the reference Work order/PO for evaluation PQC MUST BE WITH MINIMUM 1 YEAR to MAXIMUM 3 YEARS CONTRACTUAL DURATION. It must be clearly mentioned in the WO/PO. Such work MUST HAVE completed within contractual period or within any extension granted by Client without imposition of LD.

\*Similar Works: Bidder must have experience in execution of Material shifting/Handling nature of jobs along with deployment of Tipper Truck (Dumper) in any Indian Crude oil refinery.

#### **B) Technical POC:**

1. Bidder must have ownership of Tipper Truck/Dumper & Loader. Details of Tipper Truck/Dumper & Loader with necessary proof of ownership.

## C) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.27.26 Lakhs #.
