Earnest Money Deposit:	Rs.1,00,000
Contract Period:	Contract duration is only for 70 days for RTA 2023 from the date of site handover. (30 days for shutdown period and 40 days for Pre-shutdown & Post shutdown job requirement.) However, rates will be valid for 18 (Eighteen) months from the date of work order. Tentative date of RTA 2023 is Mar -Apr 2023 which might get rescheduled also. Bidders should take note of this fact

PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

The intending bidders for above tender should meet all the qualification criteria given below:

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted for inflation at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:**

Bidder must have experience of executing heat exchanger overhauling job in any Crude Oil Refinery/ Petrochemicals during last ten years ending last month from date of tender. Or, Bidder must have experience of executing heat exchanger overhauling job in any Crude oil Refinery/ Petrochemicals in shutdown/ Refinery Turn around during last ten years ending last month from date of tender in case of a composite/ LSTK contract, heat exchanger overhauling job (minimum 50 nos) to be clearly mentioned in the scope/ SOR of work order submitted by the bidder as a proof of experience. However, during bid evaluation total work order value (completed job) containing the above-mentioned job shall be considered. The entire scope of contract will be split in to 02 groups to ensure separate contractors for Group A & Group B

B) AVERAGE ANNUAL TURNOVER :

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
