#### Delivery Schedule

(i) **SUPPLY: 08 (Eight) Months** on DAP Site basis from the date of LOA/PO. The system will be shipped after complying all the comments / observations of FAT. The date of receipt of material at site shall be considered as date of delivery.

(ii) **SITE WORK: 05 (Five) Months** {04 (Four) Months for Mechanical Completion including All Installation, Cable Laying, Termination, Loop Checking and 01 (One) Month for Pre-Commissioning / Commissioning} from the date of Site readiness and Handing Over. However, an advance notice period of 15 (Fifteen) days shall be given to bidder regarding site readiness for mobilization purpose.

The date of Handling Over of successful commissioned equipment as per MR shall be considered as the completion of site work. The duration of site works shall be exclusive of the de-mobilization period. (iii) **Clause for Mobilization / Demobilization:** During Site Work, If sufficient work front is not available, vendor may be required to mobilize as well as demobilize its resource (Manpower) multiple times (Max.5 times) as per instruction of EIC. Bidder to note this requirement and to quote accordingly.

Final destination for delivery of material shall be Numaligarh Refinery Limited (NRL), Golaghat, Assam.
