Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Temporary tent/shed erection for Worker accommodation during RTA 2023
Tender No. & Date :	OC29000081 dated 25.11.2022
Due Date of Submission:	Before 1000 hrs of 09.12.2022
Earnest Money Deposit:	Rs.97,000 (rupees Ninety seven thousand only)
Contract Period:	90 days from the date of site handover.

PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

The intending bidders for above tender should meet all the qualification criteria given below:

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

- **One** similar work costing not less than **Rs.97.50 Lakhs**, or
- **Two** similar works costing not less than **Rs.78.00 Lakhs each**, or
- **Three** similar works costing not less than **Rs.58.50 Lakhs each**.

Note: Relevant work order copies and corresponding job completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** Bidder must have experience of construction of metallic prefabricated tubular Tents / Sheds in any Govt Organization or any Crude Oil Refinery / Petrochemicals / Fertilizer Industry during last ten years ending last month from date of tender. While evaluating bid, total Work Order value will be considered.

B) AVERAGE ANNUAL TURNOVER, of the last 3 financial years, shall be at least Rs.58.50 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate
