Numaligarh Refinery Limited (NRL) invites e-bids from competent and experienced Indian supplier for the following under two bid system (Part-I: Techno-commercial part and Part-II: Price Part) with sound technical and financial capabilities fulfilling the Pre- Qualification Criteria (PQC) of the tender document.

2. **SUBMISSION OF E-BID:**

The E-Bid should be prepared in Two Parts as per the following details.

- i) PART – I : Techno-commercial / Unpriced Bid
- ii) PART - II : Price Bid

Note:

- i) Only online offer shall be considered against the subject enquiry. For details please go to our e-tendering portal <http://eprocure.gov.in/eprocure/app>
 - ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

 - iv) **Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.**
 - v) Subsequent Corrigendum/Addendum (if any) shall be uploaded in CPP Portal only.
3. **Agencies submitting their bids shall not be on Holiday list of NRL or any other Oil PSE. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.**

4. **PRE-QUALIFICATION CRITERIA (PQC):**

The bidder must be a manufacturer of Tri-lobe pumps & must have supplied similar pumps to any organization in Oil and Gas service in last 10 years (to be reckoned from bid due date) for similar service requirement. The vendor to submit purchase order copies as proof of supply. Failure to do so will disqualify the vendor without any further communication.

NOTE TO BIDDERS:

The requirement of Prior Turnover and Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.

This relaxation of prior turnover and prior experience will not be applicable for items related to public safety, health, critical security operation and equipment etc.

Supporting documents for MSE bidders:

- (i) EM-2 certificate or Udyog Aadhaar Memorandum wherein bidder is registered as 'Micro/ Small Enterprise'.
- (ii) The MSE registration must be for the items/category of items/services relevant to the tendered items/category of items /services.

Supporting documents for Startup:

Bidder who intends to participate as 'Start-up' company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India.

Note: *Above supporting documents are required to be uploaded by bidder along with un-priced bid only. It is the responsibility of the bidder to upload the above supporting documents along with their un-priced techno-commercial bid for availing relaxation on Prior Turnover and Prior Experience (if applicable in this tender). In case of non-receipt of above documents along with bidder's un-priced bid, no further communication in this regard will be carried out to ascertain bidder's qualification as 'MSE bidder/ Startup' and relaxation on Prior Turnover and Prior Experience (if applicable in this tender) under the above mentioned additional condition will not be passed on to bidder.*

5. **DOCUMENTS TO BE UPLOADED AS A PART OF PART – I: TECHNO-COMMERCIAL / UNPRICED E-BID:**

- a) Documents in support of PQC.
- b) Technical documents duly signed & stamped.
- c) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. **The commercial terms & conditions should not be repeated in the offer**
- d) Bidder's Self-Declaration of black listing/ holiday listing as per Performa enclosed.
- e) Un-priced Price Schedule for list of Mandatory Spares, Commissioning Spares and Special Tools & tackles (with prices left blank).
- f) Un-priced Price Schedule for list of 2 year Normal Operation & Maintenance (O&M) Spares (with prices left blank).
- g) In case of Micro & Small Enterprise (MSE), relevant documents (i.e. EM-2 certificate /Udyog Aadhar Memorandum and Indemnity Bond in Rs.100/- stamp papers as per format enclosed) as per clause no. 7 of NIT below.
- h) Vendor Details as per Format enclosed.

6. **DOCUMENTS TO BE SUBMITTED AS A PART OF PART – II: PRICED E-BID:**

- (a) Price for Supply of - (i) Main item (including Mandatory Spares, Commissioning Spares and Special Tools & Tackles) and (ii) Per –Diem rate for supervision services in “BoQ/Priced Bid “in "XLS" format as per instructions provided.
- (b) Price break-up for recommended Mandatory Spares, Commissioning Spares and Special Tools & Tackles included in quoted price of Supply of Main Item as per ‘Price Schedule Format for Recommended Mandatory Spares, Commissioning Spares and Special Tools & Tackles’ enclosed with Tender Document and to be uploaded in ‘pdf’ format in priced bid.
- (c) Price for 2 Years Normal Operation & Maintenance (O&M) Spares as per prescribed Price Schedule format and to be uploaded in ‘pdf’ format in priced bid.

Note:

- (i) 2 years Operation & Maintenance Spares shall not be considered for evaluation
- (ii) Prices for 2 years O&M spares shall be valid up to 12 months beyond the validity of bid.

7. **TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs):**

This tender is guided by the Public Procurement Policy for Micro and Small Enterprises (MSEs) notified by the Government under the Micro, Small and Medium Enterprise Development Act, 2006, which came into effect from 1st April, 2012. The Ministry of MSME published an order known as Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 under which Micro and Small Enterprises (MSEs) shall be entitled for benefits, subject to terms and conditions as per ANNEXURE “X” enclosed.

8. **EVALUATION OF THE TENDER:** Tender shall be evaluated on ‘**Lowest Offer Basis**’ as per Loading Criteria defined in the tender document.

9. **GENERAL:**

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self-certificate in this regard.
- ii) Consortium/Joint venture bids shall not be accepted.
- iii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iv) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- v) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
