- such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- 5.0 NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
