ii) PART - II : Price Bid

Note:

- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- iv) Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.
- v) Corrigendum, Addendum (if any) will be published in e-tendering portal (http://eprocure.gov.in/eprocure/app) only.
- 3. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

4. **PRE-QUALIFICATION CRITERIA (PQC):**

- The bidder must be a ISO-9001:2008 certified company for quality management system. Valid ISO certificate to be submitted along with offer.
- The bidder must have supplied ASTM A179 tubes to any Refinery/PSU company/Petrochemicals/Govt. organization in last 05 (five) years to be reckoned from final bid submission close date. Bidder to submit purchase order copy(s) as a proof of the same.
- The bidder shall not be under Holiday listing/ Blacklisting period by any Govt. body/ PSU during the tender period. An undertaking to this effect to be submitted as per format enclosed.

The intending bidders shall have to furnish proof of their pre-qualification along with the Techno-commercial bid. Copies submitted in support of credentials shall be self-attested. Pre-qualification criteria will be checked at the time of techno-commercial evaluation of the offer. Bidders are to know that no further communication may be done to ascertain their prequalification. The offers with incomplete /irrelevant documents / anomalies may be straightway rejected without any communication.

Hence, bidders are advised to take utmost care while submitting their prequalification documents at the time of offer.

- e) Bidder's Self-Declaration of black listing/ holiday listing as per Performa enclosed duly signed & sealed
- f) In case of MSE, relevant documents (i.e. EM-2 certificate /Udyog Aadhar Memorandum and Indemnity Bond in Rs.100/- stamp papers as per format enclosed) as per clause no. 7 of NIT below
- g) Vendor Details as per Format enclosed.

7. TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs):

8. **EVALUATION OF THE TENDER:** Tender shall be evaluated on 'Item wise Lowest Offer Basis'.

9. **GENERAL:**

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self certificate in this regard.
- ii) Consortium/Joint venture bids shall not be accepted.
- iii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iv) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- v) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
