- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- iv) Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.
- v) Corrigendum, Addendum (if any) will be published in e-tendering portal (http://eprocure.gov.in/eprocure/app) only.
- 3. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

#### 4. **PRE-QUALIFICATION CRITERIA (PQC):**

#### For Filter Elements (item sl. no. 10 & 20 of BoQ):

- Bidder shall be manufacturer or authorised dealer of filter element. Authorized dealer shall submit valid dealership certificate along with the offer. Dealership certificate validity shall be at least for next one year from the date of bidding for this tender.
- Bidder shall furnish PO/WO copies of supply of similar filter element to any industry.

#### For Lube Oil Filters (item sl. no. 30 of BoQ):

• The bidder shall have supplied lube oil filters to any petroleum refinery. The filtration capacity for the supplied filter shall be less than or equal to 5 micron size. Vendor shall substantiate the same through suitable documentary proof viz Purchase order.

### 5. <u>DOCUMENTS TO BE UPLOADED AS A PART OF PART – I: TECHNO-COMMERCIAL / UNPRICED E-BID:</u>

- a) Documents in support of PQC of the tender.
- b) Technical Compliance Sheets and other technical documents/ drawings etc. duly signed and stamped.
- c) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. The commercial terms & conditions should not be repeated in the offer.
- d) Bidder's Self-Declaration of black listing/ holiday listing as per Performa enclosed duly signed & sealed
- e) In case of MSE, relevant documents (i.e. EM-2 certificate /Udyog Aadhar Memorandum and Indemnity Bond in Rs.100/- stamp papers as per format enclosed) as per clause no. 7 of NIT below.
- f) Vendor Details as per Format enclosed.

#### 7. TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs):

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self certificate in this regard.
- ii) Consortium/Joint venture bids shall not be accepted.
- iii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iv) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- v) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
