- 3) **Type, Size and Location of Land:** The plot of land should be of size 10 to 20 Bigha and should be High Land at Owguri Chapori Gaon, Rajabari, Marangi Mauza. The land has to be abetting the Rajabari Road and within 1 KM from the Rajabari ME School towards West i.e., towards the railway line. The frontage of the plot should not be less than 50 mtr.
- 4) **Special Condition:** The land should be free from any habitation and should not involve displacement of any family in the event of sale of the land.
