PRE-QUALIFICATION CRITERIA

A) **PAST EXPERIENCE CRITERIA**: Past Experience of having successfully completed similar works* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:

- One similar work costing not less than Rs.16.98 Lakhs
- Two similar works costing not less than Rs.13.58 Lakhs each and
- Three similar works costing not less than Rs.10.19 Lakhs each.

*Similar works: The bidder should have experience of successfully installing at least 5,000 liters capacity of ETC based solar water heating system

Note: Copies of Relevant Work Order (s) with SOR and corresponding completion certificates are to be enclosed with un-priced bid. The value of experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited

B) The bidder must be a Ministry of New and Renewable Energy (MNRE) empaneled Manufacturer or authorized dealer of MNRE empaneled Manufacturer of solar water heating systems with BIS approval. If the bidder is an authorized dealer, then the bidder should provide an authorization certificate from OEM while bidding, otherwise the bid shall not be considered

C) **AVERAGE ANNUAL TURNOVER**: During the last 3 years, shall be at least Rs. 10.19 Lakhs.

Note: Bidders to submit copies of audited Trading and P/L account(s) for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

D) **Bidder who is on holiday list by NRL or any other Oil sector PSU will not be considered.** Accordingly, the bidder is required to submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is not submitted or the same is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

E) **POSSESSION OF VALID GST REGISTRATION CERTIFICATE**: Bidders are requested to upload their 'VALID GSTIN/UIN Certificate' along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enroll/register before participating, through the website <http://eprocure.gov.in/eprocure/app>. Bidders are advised to go through instructions provided as 'Instructions for online Bid Submission' provided in the next page.
- 2) Bidders can access tender documents from the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website <http://eprocure.gov.in/eprocure/app>.
- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site <http://eprocure.gov.in/eprocure/app>.

Online Bids are received only on CPPP Portal website <http://eprocure.gov.in/eprocure/app> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
