#### 1. EVALUATION & ORDER AWARD:

Offer shall be evaluated on "GROUP WISE LOWEST OFFER BASIS" and the items are NOT SPLITABLE for each group as follows:

- ❖ Group A: Offer shall be evaluated for first 09 nos. of items (From Item Sl. No. 10 to 90 on overall L1 basis).
- ❖ **Group B:** Offer shall be evaluated for next 09 nos. of items (From Item S1. No. 100 to 180 on overall L1 basis).

As such, bidder has to quote for all items of a Group as per BOQ otherwise their offer shall not be considered for evaluation for that group.

Bidder has the option of quoting for one group or for both the groups based on their qualifications.

#### **2.** PRE-QUALIFICATION CRITERIA:

Bidders must have experience of supplying "any type of industrial goods" and furnish following documents along with the bid to be eligible to quote.

❖ PO copies "for any type of industrial goods", placed by Govt. agencies / PSUs not older than 10 years.

#### **SPECIAL NOTE TO THE BIDDERS:**

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.

- iii) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
