1.	SCC: Can the requirement of API 580 or API 581 qualification for the Integrity Engineers as per the SCC of tender be substituted with any other API	API 580 is recommended practices for Risk Based Inspection and API 581 is for RBI methodology. Any persons proposed for the Integrity Engineers should have API 580/ 581 certifications with relevant experiences as specified in the SCC. Other persons without API 580/581 certifications, must have the prescribed number of years of experience as detailed in the SCC.
2.	Is CV of all individual required to be submitted along with the bid documents	CV of all individuals must be submitted by the Bidder, duly sealed and signed, along with the technical bid. Documents in support of qualifications and certifications of the proposed individuals as per requirements in scope of works of the tender, shall be submitted with the bid documents. Documents in support of experience of the proposed individual shall include the name of the organization, date of joining and commencement, and contact person with telephone number or e-mail Ids. An undertaking by the bidder, certifying the submitted details shall also be part of the bid document. <i>However, submission of experience certificates of the finally selected candidates issued by respective organization has to be submitted by the successful bidder at the time of interview / joining, failing which the bidder has to arrange for another candidate with the relevant credentials.
