# **PRE-QUALIFICATION CRITERIA:-**

- A) Past Experience of having successfully completed similar works\* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
  - ➤ One similar work costing not less than Rs.10.12 Lakhs
  - Two similar works costing not less than Rs.08.10 Lakhs each and
  - ➤ Three similar works costing not less than Rs.06.07 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

\*Similar Works: Bidder must have experience in execution AMC of computers, printer & scanners in PSU, Government department or MNC in last 5 years.

The bidder must have their own offices/ support service engineer in Numaligarh, Guwahati, Siliguri, Delhi and Kolkata capable of providing required maintenance service as per terms of the contract. The proof of experience and details of maintenance support arrangement along with office address and contact number of relevant person should be submitted along with the bid.

### B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.06.07 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
