Contract Period:	06 (Six) months from the date of site handover with a provision for extension for another 6 (six) months with same terms & conditions subject to satisfactory performance of the contractor.		

PRE-QUALIFICATION CRITERIA

Compulsory Pre-Qualification Criteria for MSE/Start-up vendor: The subject job is related to public safety & security inside the refinery; therefore, relaxation pertaining to Prior turnover and prior experience shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

Bidders will be required to qualify Pre-Qualification Criteria (PQC) as indicated below:

- a. The Bidder shall have the experience of having successfully executed *similar works in hydrocarbon / petrochemical / fertilizer industry during the last 10 years ending on the last day of the month previous to one in which last date of original bid submission falls.
- **b.** Bidders shall submit Work order copies and completion certificates along with the offer as a proof of work carried out. The completion certificate must have completion date and value of work executed.
- c. Bidder is liable for rejection if completion certificate (with completion value and completion date) is not furnished with tender document
- d. **Past Experience** of having **successfully completed** similar works* during last 10 years (as on bid closing date of this tender) should be either of the following:

	Past Experience (Rs. in lakhs)
One similar completed work costing not less than	14.57
Two similar completed work costing not less than	11.65
Three similar completed work costing not less than	8.74

*Similar Works: Either of the following shall be treated as similar job:

- Industrial Material Shifting Job
- Warehousing & logistics management service works
- Material handling works

Service works related to civil and structural/ mechanical/ electrical/ instrumentation

Note: The value of past experience shall be adjusted at a simple rate of 7% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

A. <u>Average Annual Turnover</u>: During the last 3 financial years, average annual turnover shall be 8.74 lakhs

> Note: Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

B. Possession of Valid GST registration certificate:

Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

• Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.

C. ADDITIONAL REQUIREMENTS:

a. Possession of Income Tax PAN No, PF code, ESI & GST registration certificate

SPECIAL NOTE TO THE BIDDERS:

It is to be noted that experience as main contractor will only be taken cognizance of for the purpose of assessing qualifying criteria. However, authorized sub-contractors under principal contractors can also be considered provided their works completion certificate is issued by the client organization in case of job executed elsewhere under PSUs, limited companies, Government Departments, Quasi government and autonomous bodies. However, in case of sub-contractors under contractors engaged by NRL, the works completion certificate issued by the main contractor will also be acceptable provided the same is endorsed in original by Engineer-in-charge of NRL in terms of job description and value.

For accepting experience as sub-contractor(s) or contractors under Private Organizations, in addition to the requisite certificates (letter of award and job completion certificate etc.)TDS certificate issued by principal contractor/private organization shall form the basis for considering experience and value of work executed.

NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credential against PQC. Authentication may be verified with the issuing authorities, by way of direct communication to NRL over official e-mail IDs / Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.

Proper address for communication, including e-mail ID of the issuing authority should be provided along the tender document.

The Tender Document is uploaded in Central Public Procurement Portal (e-procurement) – Govt of India. Bidders are requested log in to the portal for details. Any tender related information like Corrigendum / Extension of Bid Due Date etc. will be uploaded in the CPP Portal henceforth.
