Name of Work:	Service Rate Contract for Handling Construction Equipments of NRL during Refinery Maintenance, Project, Emergency, Shutdown activities

Please note that EMD amount only in online mode is acceptable and no other mode i.e. offline or hard copy is not acceptable.)
Contract Period:	The contract shall be for a period of 2 (two) years from the handing over of site with a provision for extension by another period of one year as per requirement of NRL and satisfactory performance of the service provider to be certified by EIC.

BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

- The bidder must have Experiences of executing contract value of similar work* completed during last 10 years ending last month i.e. 30.11.2017 as follows:
 - One completed similar work costing not less than **Rs.48.47 lakhs**, or
 - Two completed similar works costing not less than **Rs.38.77 lakhs** each, or
 - Three completed similar works costing not less than **Rs.29.08 Lakhs** each.

***Similar Works : Pre-Qualification criteria – Technical:**

Bidders meeting or exceeding requisite credentials as per terms in this Qualification Criteria should only participate and shall be considered for evaluation.

Participating bidders must qualify in any of the following:

Posses experience of executing mechanical maintenance contract services in PSU refinery during last 10 years in India. The mechanical maintenance contract service mentioned herein shall mean annual mechanical maintenance contract services wherein the contract shall be inclusive of piping fabrication & erection, flange blinding & de-blinding works, process equipment repair maintenances and dismantling works.

Or

Must have executed Crane Operation & Maintenance services in any PSU refinery or Petrochemical site in last 10 years.

Or

Must be in the business of crane rental services in India and rented to any Indian PSU refinery or Petrochemical project site during last 10 years. And the crane rental service provider must own fleets of cranes out of which minimum one crane shall be lattice boom or telescopic crawler crane of over 100T rated capacity.

Note:

- (i) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof (ending last day of the month i.e. 30.11.2017).

- (ii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall form the basis for considering experience and value of work executed under the private organization.
2. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs. 29.08 lacs**. The bidder must submit copy(ies) financial documents – Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.
3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
- Provident Fund Registration Number.
 - ESI registration number.
 - Income Tax PAN Number.
 - GST Registration Number.
4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. **Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document.** It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
