Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Electrification work at landscape area and any other location(s) under the T&E department

PRE-QUALIFICATION CRITERIA:-

The intending bidders for above tender should meet all the qualification criteria given below:

The bidder must have a valid Electrical contractor license up to 11 KV.

A) Past Experience of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than **Rs.8.82 Lakhs**
- **Two** similar works costing not less than **Rs.7.06 Lakhs each** and
- **Three** similar works costing not less than **Rs.5.29 Lakhs each.**

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

***Similar Works:** The bidder should have experience in supply & Erection testing commissioning / Maintenance of any electrical Work in any central Govt./ State Govt./Govt. PSU during last 10 years as on bid closing date of this tender. Work Order copy and completion certificate shall be enclosed with the offer. The completion certificate must-have completion date and value of work executed.

***Note-1:** Vendor is liable to rejection if completion certificate (with completion value and completion date) is not furnished with tender document.

***Note-2:** For accepting experience as sub-contractor(s) or contractors under Private Organizations, in Addition to the requisite certificates (letter of award & job completion certificate etc.), TDS certificate Issued by principal contractor / private organization shall form the basis for considering experience and Value of work executed

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least **Rs.5.29 Lakhs.**

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

- C) **Possession of Valid GST registration certificate:** Bidders are requested to upload their VALID GSTIN/UIN Certificate along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
