Two parts bid **ONLINE** (E-tender) item rate offers requested from competent contractors for following work:

BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

- The intending bidders for above tender should meet the qualifications as given below:
 Past Experience of having successfully completed similar works during last 10 years ending last month should be either of the following:
 - One completed similar work costing not less than **Rs.56.00 lakhs**, or
 - Two completed similar works costing not less than **Rs.44.80 lakhs** each, or
 - Three completed similar works costing not less than **Rs.33.60 lakhs** each.
- *<u>Similar Works</u>: The bidder shall meet the following minimum acceptable criteria for being technically qualified:
- i) Offer from original licensor i.e. **M/s. AspenTech** or **AspenTech Approved Implementation Service Partner (ISP)** (approval documents to be provided for the same), who has successfully implemented AtOMS & AORA technology at least in one refinery shall be considered.

Additional requirement:

- a) The bidder should be M/s. AspenTech itself or an authorized ISP of AspenTech with their office in India for at least 1 year (supporting documents to be provided by the ISP).
- b) The vendor cannot outsource any part of the work to any freelancer or any another party.
- c) Bidders must have technical support base in India with sufficient and qualified technical manpower to facilitate implementation and post warranty technical support. Bidder has to submit an undertaking giving details of its technical support base and qualified technical manpower in India.
- d) Bidder shall have to submit credentials of their AtOMS/AORA team along with organizational chart. The team should have adequate manpower experienced in design, engineering, and implementation. Team member should have minimum 3 years of experience in Aspen products implementation.

Bidders shall furnish their other installation list for similar projects with details of contact persons including telephone/fax/mail id etc.

Offer shall be considered only when NRL is satisfied with experience and capability of the bidder to take up the work.

Note:

Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year (ending last day of the month, proceeding the month in which bids are invited).

(i) Bidders should duly seal & signed the integrity Pact. Bidder's failure to return the Integrity pact duly signed shall result in the bid not being considered for evaluation.

- (ii) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof.
- (iii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall from the basis for considering experience and value of work executed under the private organization.

- 3. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least Rs. 33.60 lacs. The bidder must submit copy(ies) financial documents Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.
- 4. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
 - i. Provident Fund Registration Number.
 - ii. ESI registration number.
 - iii. Income Tax PAN Number.
 - iv. GST Registration Number.
- 5. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
