1. EVALUATION & ORDER AWARD:

Evaluation will be done on "OVERALL LOWEST OFFER BASIS" and items are NOT SPLITABLE. As such bidder has to quote for all items as BOQ otherwise offer shall not be considered for evaluation.

2. PRE-BID MEETING:

- ii. During the pre-bid meeting, vendor may propose alternate specifications or design, deviations, exclusions, additional detailing. Bidder is advised to mail the queries and deviations prior to attending the meeting. The final acceptance of such changes same rests with NRL. Such correspondence may be published and made known to other bidders through NRL website or through tender portal.
- iii. NRL reserves the right to ignore queries raised by any participant of the pre-bid meeting subsequently unless same is linked to the earlier pre-queries & responses or is linked to any resultant corrigendum to the tender.
- iv. NRL further reserves the right to ignore queries as well as any deviations sought by interested bidders who have not participated in the pre-bid meeting process.
- v. Modifications, if any, would be carried out to the tender document based on the pre-bid discussion and the minute (MOM) of the discussion shall form a part of the bid document and shall be uploaded in the CPPP and NRL website after the pre-bid discussion.

3. PRE-QUALIFICATION CRITERIA:

- A. Bidder shall be a panel manufacturer/authorized dealer/distributor of minimum voltage grade 11KVac electrical panels/switchboards. In case of authorized dealer/distributor offering on behalf of OEM, the bidder shall submit copy of valid dealership /distributorship certificate/authorization letter from the OEM along with the offer. In case both dealer/distributor and manufacturer quote, offer of the manufacturer only shall be considered.
- B. The panel manufacturer should have type test approval from Electrical Research and Development Association (ERDA) or Central Power Research Institute (CPRI). The bidder has to furnish the approval document of ERDA/CPRI along with the technical bid.
- C. (a) The bidder, **if Manufacturer**, shall have experience of design, manufacturing, supply, testing and commissioning of minimum 1 set of 11KV Electrical Panel in any Govt. Dept./Govt. Institute/Govt. Organization /PSU.

OR

The bidder, **if Authorised Dealer or Distributor**, shall have experience of supply, testing and commissioning of minimum 1 set of 11KV Panel of offered Manufacturer in any Govt. Dept./Govt. Institute/Govt. Organization/PSU.

Note:

- 1. Bidder shall furnish details of past experience, of all the jobs he intends to submit, invariably in the above format.
- 2. Bidder shall submit copies of work orders and completion certificates of each job listed in the above format only.
- 3. The completion certificate should be issued by the client and should consist of Name of Work, WO no. & date, awarded value, actual executed value, contractual completion period, actual completion period (with a mention of penalty for delay, if any).
- 4. In case of non-availability of Completion Certificate issued by client, alternatively, MOM or Handover/Takeover Note, jointly signed by the bidder and the client after successful commissioning/handover of the system indicating executed value, date of completion, shall be considered for evaluation of past experience.
- 5. In case of non-submission of complete documentary evidence against each work order listed in the above format or if any supplementary information is required by NRL during technical evaluation of bids, the bidder may be requested by NRL to furnish the required information/ documents.
- 6. No additional work order apart from the jobs listed in the above format shall be considered for technical evaluation of the bids.
- 7. Non submission or incomplete documents regarding past experience as mentioned above may lead to rejection of that particular job for considering as his experience.

SPECIAL NOTE TO THE BIDDERS:

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.

d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.

- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
