PRE-QUALIFICATION CRITERIA:-

The intending bidders for above tender should meet all the qualification criteria given below:

- **A) Past Experience** of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - ➤ One similar work costing not less than Rs.39.96 Lakhs, or
 - **Two** similar works costing not less than **Rs.31.97 Lakhs each**, or
 - ➤ Three similar works costing not less than Rs.23.98 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

*Similar Works: 1. The contractor must have a valid Electrical contractor license of a minimum of 11KV, as on the date of publication of the tender. 2. The contractor should have experience not older than 10 years in electrical operation and maintenance work(s) or electrical maintenance work(s) in any Central Govt.org or State govt. org or PSU. Note: The Relevant work order copies, corresponding completion certificates and valid Electrical contractor license are to be enclosed with the offer. The vendor is liable to rejection if the Relevant work order copies, corresponding completion certificates and valid Electrical contractor license are not furnished with the tender document.

B) AVERAGE ANNUAL TURNOVER, of the last 3 financial years, shall be at least Rs.23.98 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
