## PRE-QUALIFICATION CRITERIA

- A) <u>PAST EXPERIENCE CRITERIA</u>: Past Experience of having successfully completed similar works\* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
  - One similar work costing not less than Rs.8.9 Lakhs
  - Two similar works costing not less than Rs.7.12 Lakhs each and
  - Three similar works costing not less than Rs.5.34 Lakhs each.
  - \*Similar works: Bidder must have experience in any PSU, authorized CGD owner or Govt. organization in India during last ten years. Similar Work Definition: PE80 Yellow MDPE underground natural gas pipeline work, over ground PNG GI piping works and commercial/domestic PNG connection work as per PNGRB T4S regulation. Bidder has to submit copy of work order/ Letter of award and completion certificate as documentary evidence of experience. For accepting experience under Private Organizations, in addition to the requisite certificates (Work order copy/letter of award and job completion certificate etc.) TDS certificate issued by the private organization should be submitted with bid documents.
  - Note: Copies of Relevant Work Order (s) with SOR and corresponding completion certificates are to be enclosed with un-priced bid. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited
- B) <u>AVERAGE ANNUAL TURNOVER</u>: During the last 3 years, shall be at least Rs. 5.34 Lakhs.

  Note: Bidders to submit copies of audited Trading and P/L account(s) for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
- C) Bidder who is on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder is required to submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is not submitted or the same is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.
- D) <u>POSSESSION OF VALID GST REGISTRATION CERTIFICATE</u>: Bidders are requested to upload their 'VALID GSTIN/UIN Certificate' along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

Bidders are advised to go through instructions provided as 'Instructions for online Bid Submission' provided in the next page.

- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>.

Online Bids are received only on CPPP Portal website <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
