Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Certificates

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

4. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

PQC criteria:

1. Bidder must be a Manufacturer (OEM) or Authorized Dealer of offered items. For authorized dealer, valid dealership/ authorization certificate to be submitted in support of the same. 2. Bidders must furnish 2 nos. of PO copies and their delivery challan / payment invoice of lugs / glands / cable connectors/terminals placed by Govt. agencies / PSUs not older than 05 years.

Disclaimer
