Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, environmental & pollution management. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

The intending bidders for above tender should meet all the qualification criteria given below:

- **A) Past Experience** of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - ➤ One similar work costing not less than Rs.26.92 Lakhs, or
 - **Two** similar works costing not less than **Rs.21.53 Lakhs each**, or
 - ➤ Three similar works costing not less than Rs.16.15 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

*Similar Works: The bidder should have experience in Designing, Detail engineering, monitoring, supervising and successful commissioning of at least one Sewage Treatment Plant for an Industrial/Residential Complex having capacity of handling minimum 200 KLD of STP in any PSUs/ central Govt. / State Govt. organisation as a consultant. Works performed by bidder directly for the prime client shall only be considered. Works performed through subletting from Principal Consultant shall not be considered valid for this criterion.

Note: The Relevant work order copies and corresponding completion certificates are to be enclosed with the bid. The bidder is liable for rejection if the Relevant work order copies and corresponding completion certificates are not furnished with the tender document.

B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.16.15 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate
