BRIEF SCOPE OF WORK:

Extension of E-Carousel Bay at NRL LPG Bottling Plant as per tender document.

PRE-QUALIFYING CRITERIA:

Agencies should fulfill the Qualification Criteria (Experience and Financial) given below:-

A. Experience Criteria:

- ❖ Bidder should have experience of successfully execution of “**Civil & Structural Construction job**” during last 10 years ending last day of previous month.
- ❖ The minimum values of such services shall be as given below:-
 - Three completed similar works each costing not less than **Rs. 14.08 Lacs** each, or
 - Two completed similar works each costing not less than **Rs. 18.78 Lacs** each, or
 - One completed similar work costing not less than **Rs. 23.47 Lacs**.

To establish the above, bidders are required to furnish the following with their technical bid:

- i) Documentary evidence (detailed Work order & completion certificate) in support of experience.
- ii) Job completion certificate should indicate name of work, work order no. final contract value, date of starting of the job, completion date signed by competent authority of the prime owner.

[The value of past experience will be adjusted at a simple rate of 7% for every completed year ending last day of the month proceeding the month in which bids are invited]

B. Financial Criteria:

AVERAGE ANNUAL TURNOVER in at least one of the preceding three financial years should be equal to **Rs. 14.08 Lacs**.

C. OTHER REQUIREMENTS:

Net Worth of the bidder during financial year 2015-16 should be positive.

Bidder should not be under liquidation, court receivership or similar proceedings. Bidder shall furnish documentary evidence by way of copies of Work Orders and Completion Certificates etc. along with their bid to establish bidder's conformance to Qualification Criteria.

Failure to meet the above Qualification Criteria will render the Bid to be rejected. Therefore, the bidder shall in his own interest furnish complete documentary evidence in the first instance itself, in support of their fulfilling the Qualification Criteria as given above.

Bids on Consortium or Joint venture basis are not acceptable.

- D. Service Tax Registration no., Income Tax PAN No., Sales Tax Clearance Certificate etc. of bidder to be furnished.
