PRE-QUALIFICATION CRITERIA:

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

The intending bidders for above tender should meet **all** the qualification criteria given below:

a. Technical PQC:

i. Bidder shall be in the business of providing crane hiring services with crane capacity of 80 Te. or above crane to any construction work /Oil& Gas sector/Petrochemical/ Fertilizer industry during last 10 Years ending last day of month previous to the one in which the original bid due date falls. Bidder shall furnish work order copy along with corresponding job completion certificate in compliance of above.

OR

ii. Bidder shall have experience in Operation & Maintenance of 80 Te capacity or above crane in any construction work/Oil& Gas sector/Petrochemical/ Fertilizer industry during last 10 Years ending last day of month previous to the one in which the original bid due date falls. Bidder shall furnish work order copy along with corresponding job completion certificate for supplying in compliance of qualification criteria.

OR

iii. Bidder shall have experience in erection/dismantling of equipment weighing more than 30MT (single equipment weight) in any construction work Oil& Gas sector/Petrochemical/Fertilizer industry during last 10 Years ending last day of month previous to the one in which the original bid due date falls. Bidder shall furnish work order copy along with corresponding job completion certificate in compliance of above.
