- 2.8 EARNEST MONEY DEPOSIT: Not Applicable.
- 2.9 HOLIDAY LISTING: Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per the format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject the bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

3.0 PRE-QUALIFICATION CRITERIA (PQC):

Bidder must have experience of supplying Gas cylinders as mentioned in SOR in last 5 years in PSUs, Govt. Industries, Fertilizers etc.

The bidder must furnish a copy of purchase order/Work order along with Inspection release note (IRN)/Invoice as a proof to the same.

4.0 PTR (PAST TRACK RECORD) RELAXATION FOR MSE / STARTUPS:

Pre-Qualifying Criteria mentioned in the tender is mandatory for all participating bidders including MSEs and Start Ups as industrial cylinders are critical from safety point of view in hydrocarbon Refinery.

6.0 MSE Bidders

Purchase preference to Indian MSEs (Micro & Small Enterprises) shall be applicable as per the Govt. of India Policies. *Refer details in Annexure-X*.

7.0 PP-LC Policy (Not Applicable for this tender)

Under this policy, bidder can avail the PPLC purchase preference as applicable from time to time. However, for that bidder must submit following:

- (i) At bidding stage:
- a) Bidder shall furnish the percentage of the local content in the bid, taking into account the factors and criteria listed out in the policy.
- b) The bidder shall also submit the following:

The bidder shall submit an undertaking from the authorized signatory of bidder having the Power of Attorney along with the bid stating the bidder meets the mandatory minimum LC requirement and such undertaking shall become a part of the contract. Declaration as given in Format- 2A

In cases of procurement for a value in excess of Rs. 10 Crores, the Undertaking submitted by the bidder shall be supported by a certificate from the statutory auditor or cost auditor of the company (in the case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of other than companies) giving the percentage of local content. Format for providing the certification from the statutory auditor / cost auditor / practicing cost accountant / practicing chartered accountant, is enclosed as Format-2B.

However, in case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. In case office or subsidiary in India does not exists or Indian office/ subsidiary is not required to appoint statutory Auditors or cost auditor, certificate from practicing cost accountant or practicing chartered accountant giving the percentage of local content is also acceptable.

Please note that the onus of submission of appropriately certified documents lies with the bidder and the purchaser shall not have any liability to verify the contents and will not be responsible for the same. However, in case the procuring company has any reason to doubt the authenticity of the Local Content, it reserves the right to obtain the complete back up calculations before award of work failing which the bid shall be rejected.


8.0 Procurement from a bidder from a country which shares Land Boundary with India

Comparison shall be made against the final Landing Costs at NRL Site (including all other applicable charges like P & F, Transportation charge, TPI charge, Transit Insurance etc.-as mentioned in BOQ).

3.0 GERERAL

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credential against PQC. Authentication may be verified with the issuing authorities, by way of direct communication to NRL over official e-mail IDs / Original letter of authentication by post. Bidders may also follow up with the issuing authority to elicit an early response. If documents remain unauthenticated till the given timeline, NRL reserves the right to reject the bid. A proper address for communication, including e-mail ID of the issuing authority should be provided along the tender document.
- b) Consortium/Joint venture bids shall not be accepted.
- c) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- d) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept on holiday list/ blacklist apart from other penal actions as deemed fit by NRL.
- e) In case any bidder is found to be involved in cartel formation, his bid will not be considered for evaluation/placement of order. Such bidders will also be debarred from bidding in future.
