Earnest Money Deposit:	Rs.1,00,000.00 (Rupees One Lakhs Only) The EMD must be submitted online on the portal of HDFC bank (instructions at Annexure-XVII below) and its receipt must be uploaded along with offer. If the EMD is not received along with the offer, offer shall not be considered for opening.	
	However, MSE bidders are exempted from submission of EMD. MSE bidders are required to upload Udyam Registration Certificate (as explained in Annexure-X) instead of the EMD deposit receipt.	
Contract Period:	12 months from the date of site handover.	

PRE-QUALIFICATION CRITERIA:-

- A) <u>Pre-Qualification Criteria (Technical):</u> The bidder who intends to participate in the tendering process shall meet all the following minimum requirements and only such bidder shall be pre-qualified for further evaluation
 - 1. **Work Experience**: Bidder should have experience in Electrical job (LSTK or Project job or EPC or Maintenance or electrical works) in any Hydrocarbon Refinery in India and have successfully executed similar works during the past 10 (Ten) years as on the last day of the month preceding the last bid submission date.
 - The bidder must submit copy (s) of relevant work order (s) AND work completion certificate from the end user in support of the above criteria.
 - 2. Bidder shall have Valid Electrical Contractor License of class-II or minimum 650 Volts issued by Competent Authority. Same to be furnished in the bid.
- **B)** Past Experience of having successfully completed similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
 - ➤ One similar work costing not less than Rs.224.48 Lakhs
 - > Two similar works costing not less than Rs.179.58 Lakhs each and
 - ➤ Three similar works costing not less than Rs.134.69 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

*Similar Works: Bidder should have experience in Electrical job (LSTK or Project job or EPC or Maintenance or electrical works) in any Hydrocarbon Refinery in India and have successfully executed similar works during the past 10 (Ten) years

C) <u>AVERAGE ANNUAL TURNOVER</u>: During the last 3 financial years, shall be at least Rs.134.69 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

D) <u>Possession of Valid GST registration certificate</u>: Bidders are requested to upload their <u>VALID GSTIN/UIN</u> <u>Certificate</u> along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
