Technical Corrigendum Dated 31.01.2023

(After Pre-Bid Meeting Conducted on 30.01.2023)

Clause 15.0, Sl. No. 3, Point 'e & f' Annexure -1 of Tender specification Document are updated as follows:

GTP For Vacuum contactor -

It shall be of HT vacuum contactor in accordance with IEC 62271-100 refers duties AC1 to AC4 for motor starting & for capacitor switching. The contactor shall be suitable for back-to-back switching of the capacitor bank & restrike free (C2 class). vacuum contactors are type tested for Back to back capacitor switching (C2 class).

Bidder has to submit the Type tested for Back to back capacitor switching (C2 class) in accordance with IEC 62271.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
