#### 1. **EVALUATION & ORDER AWARD:**

Offer shall be evaluated on "overall lowest offer basis" & the items are NOT SPLITABLE.

#### 2. PRE-QUALIFICATION CRITERIA:

- The Intrinsically Safe refrigerator shall be certified by ATEX / IECEx / PESO. The vendor shall provide ATEX / IECEx / PESO approve certificate along with the bid.
- The vendor shall be the original equipment manufacturer (OEM) or the authorized dealer for the OEM. Authorized and valid dealership certificate to be provided along with the bid.

**Note:** Participating bidders shall have their Authorized service agent or a permanent office with service facilities in India. Bidders without this will not be considered for evaluation (Confirmed – YES / NO).

#### **SPECIAL NOTE TO THE BIDDERS:**

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder**: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.
