PRE-QUALIFICATION CRITERIA:-

- A) Past Experience of having successfully completed similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:
 - > One similar work costing not less than Rs.27.72 Lakhs (Exclusive of GST/ Service Tax), or
 - > Two similar works costing not less than Rs.22.18 Lakhs (Exclusive of GST/ Service Tax) each, or
 - > Three similar works costing not less than Rs.16.63 Lakhs (Exclusive of GST/ Service Tax) each.

Note: Relevant work order copies and corresponding schedule of rates (SOR), completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls. Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable. The values mentioned here are exclusive of GST / Service Tax.

*Similar Works: The Bidders should have similar working experience with Government Organizations/ PSUs in India:

Similar Works shall mean the work of Topographical Survey and Geotechnical Investigation comprising drilling in soil/rock/boulders, in-situ testing, etc. as specified in BOQ and submission of geotechnical data etc.

B)The Bidder should have on its regular payroll for minimum 2 (Two) years period reckoned as last date of notified for receipt of bid, at least one (1) Qualified Geotechnical Engineer with PhD/ M. Tech/ M.S. degree in Geotechnical Engineering and having minimum Ten (10) years' work experience in the area of geotechnical investigation in the Geotechnical investigation team.

C) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.16.63 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three financial years mentioned above refers to immediate three preceding financial years wherever the last bid submission date is after 31st December. In case of tenders having last bid submission date up to 31st December and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the three years prior to preceding financial year will be considered. [May refer illustrative example given at Annexure-VII]

Note:- If a Bidder does not submit the aforementioned financial statements for three specified years, then Average Annual Turnover will be calculated based on financial figures of only those specified years for which requisite financial statements are submitted. Turnover will be considered '0' (Zero) for the year(s) for which requisite financial statements are not submitted.

Audited Annual Report / financial statements needs to be accompanied with UDIN number, which is mandatory from July 2019 onwards. Any Financial Report which is issued after July 2019 onwards without UDIN shall not be considered for evaluation.

D) Possession of Valid GST registration certificate

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
