Expression of Interest (EOI) for Land/Accommodation facility for contract workers of Numaligarh Refinery Expansion Project, Numaligarh, Golaghat, Assam, India

Numaligarh Refinery Limited (NRL) is a group company of Bharat Petroleum Corporation Limited. Its Refinery is located at Numaligarh, District Golaghat, and Assam with a capacity of 3 MMTPA. Under Govt. of India's "Hydrocarbon Vision 2030 for North East" and "Act East Policy" NRL has received CCEA approval for setting up of 6 MMTPA Refinery as expansion project. Various pre-project activities related to expansion are going on. For Implementing various project activities substantial workers shall have been accommodated nearby project site. NRL is looking for suitable land/accommodation facility on lease rental basis (for minimum 3 years with renewal option) for the purpose.

This EOI is floated to shortlist prospective owners having suitable land for contract workers camp and accommodation facility suitable for contract workers. Prospective owner of such facilities are requested to submit details of such facilities along with indicative rent.

Sealed offers are invited from interested parties, holding possession of the property as per conditions indicated in below (A. NOTE).

The proposed locations of such facilities are mentioned below:

A. **NOTE:**

- 1. Considering huge volume of interconnected activities and logistical advantage, preference will be given to the bigger size Land /Dormitory accommodation facility/House surrounding Numaligarh Refinery.
- 2. Accessibility to minimum 440 V / 11KV power source near the offered plot.
- 3. Area: If the entire parcel of Land /Dormitory/House does not belong to one owner then the group of owners can quote through one Registered/Notarized Power of Attorney holder. However, Numaligarh Refinery Limited shall only deal with the Power of Attorney holder. Copy of the required Power of Attorney from each owner duly endorsed should be enclosed with the offer.
- 4. **Lease period :** Initially 03 (three) years, which may be extended with mutually agreed terms & conditions for any period as sought by NRL
- 5. **Indicative Lease Rent:** Monthly indicative lease rent to be submitted along with the offer for the complete area of Land /Dormitory accommodation facility/House.
- If the deal with the property owner is finalized then Non-Encumbrance Certificate, No Litigation
 Certificate, other land related documents, etc. shall be furnished by the owner on request from NRL
 in due course.
- 7. Interested party is requested submit Details of Land as per format in Appendix-1 and details of Accommodation Facilities as per Format in Appendix-2.



- 8. NRL reserves the right to evaluate the properties offered by the interested parties as per its requirement which fits most suitable. On mere submission of the EOI the interested parties do not possess right to consider their facility(ies). NRL also reserves the right to reject any or all of the offers without assigning any reasons thereof.
- 9. NRL also reserves the right to transfer the data to its prospective contractors of NREP who in turn may be interested to take the facilities of their own. In such case the interested parties shall be contacted by the contractors directly to settle the matters.
- 10. Brokers / Property Dealers need not apply.
