- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

# Minutes of Meeting of Pre bid meeting

**Meeting Title**: PreBid Meeting-Gem Bid [GEM/2025/B/5908588]-PUR-MECHMNT-1009076-Supply of HCU Reactor Effluent Air Cooler (REAC) Tube Bundles (Alloy-825)

## Key points:

- Introduction of Participants: Manab, Pawan, and Sarfrazullah introduced the meeting and reque sted participants to introduce themselves. Laxmikant and Akshay Pariskar from M/s Enginemates H eat Transfer, and Saket from M/s Patel Air Temp Limited, were among the attendees.
- **Vendor Participation:** It is confirmed that meeting links were sent to vendors and Engine Mates Heat Transfer & Patel's Attempt Limited joined. Tinita was expected but had not joined yet.
- **Drawing Conflicts:** Dilip Swami from M/s Patel Air Temp Limited raised a concern about conflictin g dimensions in the drawings provided in the tender documents. It is clarified that the new design might have different dimensions due to updated requirements.
- **Mechanical Calculations:** Laxmikant from Enginemates Heat Transfer inquired about the need to reverify mechanical calculations. It is confirmed that the minimum thicknesses provided should be used as a reference, and calculations should be prepared accordingly.
- **Unloading Scope:** Laxmikant raised a concern about the scope of unloading bundles at the site. It was clarified that same will be detailed in subsequent corrigendum.
- **Vendor List for Material Sourcing:** Laxmikant asked if there was a specific vendor list for mater ial sourcing. It was clarified that there is no specified vendor list, and suppliers should follow the tes ting requirements mentioned in the ITP.
- **Payment Terms:** Saket and Laxmikant requested changes to the payment terms, including addin g a milestone for material ordering and increasing the initial payment percentage. It is explained th at advance payments is very difficult as per NRL policy, but the request would be reviewed for mile stone payment and if there is any amendment, same will be published in subsequent corrigendum.
- **Country of origine of Raw material:** Both the prospective bidder require clarification on countr y of origine of raw material procurement and it was clarified that if something is required as an additional terms, same will be published subsequently as a corrigendum.
- **Pre-Bid Queries and Extension:** Participants requested an extension for submitting pre-bid queri es and the bid submission date. It was agreed to consider the request and asked participants to sen d their queries via email by 13-02-2025 and one corrigendum will be published subsequently cover ing all points received via email. It is requested for earliest submission of queries by prospective bi dders via email considering the matter on priority.
