Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Assistance in Project related Electrical jobs in and around NRL Site

Pre-bid meeting	Not required for this tender.
Online Bid and EMD Submission:	Before 11:00 AM of 5th March, 2024
Earnest Money Deposit:	Rs. 2,00,000.00 (Rupees Two Lakh only)
Contract Period:	12(Twelve) months from the date of site handover. There is a provision for extension of contract for another 12 months at same rates, terms and conditions, as per requirement of NRL and satisfactory performance of the contractor certified by EIC.

PRE-QUALIFICATION CRITERIA:

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

The intending bidders for above tender should meet **all** the qualification criteria given below:

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:

- **One** similar work costing not less than **₹50.12 Lakhs**, or
- **Two** similar works costing not less than **₹40.09 Lakhs each**, or
- **Three** similar works costing not less than **₹30.07 Lakhs each**.

***Similar Works:** Bidder should have experience in electrical works in Oil and gas installations like Crude oil refinery, Oil & Gas storage terminals or petrochemical plants in India.

B) Other Technical PQC:

Bidder should have valid electrical license for execution of electrical works of minimum 33 kV level.

C) Average Annual Turnover, of the last 3 (three) financial years, shall be at least **₹30.07 Lakhs**.

D) Possession of Valid GST registration certificate: Bidders are requested to upload their VALID GSTIN/UIN Certificate / GSTIN Number along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal. Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.
